

NSW WORKING WITH CHILDREN CHECK- VOLUNTEERS DECLARATION

Position Details:

Title of child- related position: **Examiner**

Name of organisation you are a volunteer for: **Royal Life Saving NSW Branch**

It is an offence for a prohibited person to apply for, attempt to obtain, undertake or remain in child-related employment, or to sign this declaration. A prohibited person is a person who is convicted of the following (whether in NSW or elsewhere):

- Murder of a child
- Serious sex offence, including carnal knowledge
- Child-related personal; violence offence (an offence committed by an adult involving intentionally wounding or causing grievous bodily harm to a child)
- Indecency offences punishable by imprisonment of 12 months or more
- Kidnapping (unless the offender is or has been the child's parent or carer)
- Offences connected with child prostitution
- Possession, distribution or publication of child pornography; or
- Attempt conspiracy or incitement to commit the above offences.

A prohibited person includes a Registerable person under the Child Protection (Offenders Registration) Act 2000.

Details of these offences can be found online at Working With Children Employer Guidelines Fact Sheet1. A conviction includes a finding that the charge for an offence is proven, or that a person is guilty of an offence, even though the court does not proceed to a conviction.

Declaration:

- I declare that I am not a prohibited person under the Commission for Children and Young People Act 1998.

I understand that a person who intentionally makes a false statement is guilty of an offence and I believe that the statements in this declaration are true in every particular.
